

Cost of Doing Business National Ranking

CNBC's 2019 "Top States for Business" report ranks West Virginia's cost of doing business at 6th best, a 5-point improvement over the state's 2018 rank of 11th. CNBC analyzes the tax burden in each state (individual income and property taxes, business taxes, and gasoline taxes); utility costs, the cost of wages, and rental costs for office, commercial and industrial space.

Wages

West Virginia's median hourly wages (expressed in U.S. dollars (\$)) for select occupations important to the Petrochemical and other manufacturing industries are typically lower than those in surrounding states — a significant point since wages and salaries account for about 70 percent of a company's expenses.

Unemployment Compensation

The Unemployment Compensation system in the United States is designed to provide temporary and partial wage replacement to recently unemployed workers, as well as help stabilize the national economy during recessions. The United States Department of Labor oversees the system, but each State administers its own program.

West Virginia sits atop the second largest gas field in the world. According to the U.S. Energy Information Administration, West Virginia's average price of natural gas sold to industrial consumers is below the national average, and is significantly lower than in surrounding states.

Cost of Living

West Virginia is an excellent place to live, work and play.

- According to Sperling's Best Places, the cost of living in surrounding states is higher than in West Virginia.
 The cost of living rates are as follows:
- o Kentucky 10.5% below the national average (Index rate of 89.5)
- o Maryland 24.6% above the national average (Index rate of 124.6)
- o Ohio 12.3% below the national average (Index rate of 87.8)
- o Pennsylvania 0.30% above the national average (Index rate of 100.3)
- o Virginia 13.8% above the national average (Index rate of 113.8)
- o West Virginia **16.4% below** the national average (Index rate of 86)
